

Alyce Reynolds Understanding Deafhood

This presentation covers key areas of 'deafness' vs. 'deafhood', history of the Deaf (including oralism & audism) and suggests how to start one's Deafhood journey. 'Being Deaf' carries a negative medical connotation while 'Deafhood' carries a positive cultural and linguistic one. History of the Deaf, especially Deaf Europe and Deaf America pre- and post-Milan 1880, will be re- visited.

Evidence points to a pre-Milan 1880 Europe where Deaf people experienced positive life in general society. Parallels between the European colonial era with post-Milan colonization of the Deaf through Oralism will be discussed. Ways that the current society continues to colonize the Deaf raises participant awareness. "Decolonization" can be achieved by traveling deeper into our individual and collective Deafhood journeys, starting with discourses and self-examination. Our mind needs to re-frame what it means to be an equal and wholesome human being.

Bio:

Alyce Slater Reynolds taught at the California School for the Deaf-Fremont. She served on the Bi-Lingual/Bi-Cultural committee which shaped CSD-F's Bi-Bi program. After CSD-F, she was a Professor at Ohlone College. She's now retired but continues active with presenting, traveling, and being a grandmother of twins.

Dawn Duran and Stephanie Mathis

It Takes Two to Tango: The What, When and Why of Providing Resources

Sharing resources is a value within the Deaf community. It is also part of an interpreters Code of Professional Conduct to share

resources judiciously. Participants in this workshop will be able to identify to resources in our community, and how to provide those resources without doing harm to the individual, client, community and profession. The participants will have an opportunity to consider ethical questions and options addressing those ethical issues surrounding sharing resources.
